**KEXP's Podcasting License
(Sound Recordings and Musical Works)**

This Agreement is made and entered into as of this 7 day of April, 2012 between and among Jordan Cook and each of its members (collectively, the "Licensor") and Friends of KEXP (dba KEXP 90.3 FM), a not-for-profit corporation located at 113 Dexter Avenue North, Seattle, WA 98109 (the "Licensee").

WHEREAS, Licensee desires to produce one or more digital audio recordings, which may be broadcast, webcast, streamed and/or made available for download by the general public without charge at www.KEXP.org or such other web sites or locations as Licensee shall determine (each a "Podcast");

WHEREAS, Licensee may wish to incorporate into its Podcasts the following sound recordings and/or musical works:

KEXP Live Performance from Jordan Cook including interview and the following tracks:

Electric Cove
Old Man
The Chain (Fleetwood Mac)
In The Dark

and any other sound recordings, musical works or other materials which the parties agree in writing (including by emails exchanged between the parties) may be included in the Podcasts (collectively the "Works"), the rights to which are held by Licensor; and

WHEREAS, Licensor sees potential promotional value in allowing the Works, or portions thereof, to be made a part of the Podcasts;

THEREFORE, the parties hereto do mutually agree as follows:

1. In consideration of the potential promotional value to Licensor and the other covenants herein on the part of Licensee, Licensor hereby grants to Licensee a perpetual, nonexclusive, worldwide, royalty-free license to reproduce, distribute, broadcast, webcast, stream, transmit and perform the Works, or any portion thereof, in connection with the Podcasts in any manner, method or media. This license shall include the right to sublicense the foregoing rights.
2. Licensor further agrees that Licensee may incorporate in the Podcasts any performances or interviews which were previously recorded or may be recorded in the future by Licensee with the permission of Licensor, and that such performances and interviews, and all underlying sound recordings and musical works incorporated therein, shall be included within the definition of Works.
3. Licensor also hereby grants Licensee the right to use the name, voice, likeness, biographical data and musical performance of Licensor and its members in connection with the distribution, performance, broadcast, webcast, streaming and promotion of the Podcasts.
4. Licensee shall have no right to alter the Works, except that Licensee may combine the Works with other compositions and recordings and include voice introduction, outros and voiceovers, and it may choose, at its option, to utilize only selected portions of a Work in a particular Podcast.
5. Each party hereto warrants and represents that it has the full right, power and authority to enter into this Agreement
